Additional preferred (but not necessarily required) qualifications include:

- Two or more years of experience in legal practice, preferably in public agency, municipal, and/or land use law.
- Connections to San Joaquin County or surrounding communities.

To perform well in this position will also require an applicant to possess or develop strong public speaking skills; knowledge of civil and administrative procedures applicable to municipal government, particularly including the Brown Act and the California Public Records Act; the ability to communicate clearly and calmly, particularly in stressful or emotionally-charged situations; flexibility to respond to situations and communicate with clients outside of traditional "business hours"; clear, concise, and effective writing skills;

and strong interpersonal skills, including the ability to actively listen, process information, persuade, educate, and problem-solve.
